Vice President Miller called the meeting to order at 9:15am. Called for a review of the July 2007 minutes.

**MOTION:** by Jo-Ann Pollack to accept the July 2007 minutes. **Second:** Artie Deyns **VOTE: Abstain:** Wendy Purdy (not present July meeting) **For:** All others in favor. *Motion passed*.

# **Property Manager's Report**

Pam Valenza –

• Mike Smith is absent due to a death in the family. Vinny D'Eusanio is absent due to flight delays due to the bad weather.

- Security less reported speeding since additional vehicle has been in.
  6 break-ins reported in July security has an ongoing investigation.
  BB gun holes found in a trailer.
  Back window in a car was smashed out.
  Graffiti found on the outside of comfort station 2 last night.
  19 citations were issued in July 4 speeding, 4 reckless endangerment, 6 disorderly conduct, 3 underage drinking, 1 trash violation and 1 trespassing violation.
- Concession breaking even as of yesterday.

Mark Christie – asked about the camera at the compactors.

Pam Valenza – stated that the cable company is removing the equipment at the area next to Well 4 on Pequest. TC Lloyd has to come in to disconnect the electric to the building & equipment first. When that is done, the cable company will install the cable wire for no charge. One camera is operating now.

- Bar is ahead as of last night by \$4,400.00. Asked the Board's opinion on having a New Year Eve party. *Discussion held*. Board agreed to have the New Year's Eve party. Will start advertising for the party & get tickets printed.
- Dues 46 lots still owe current dues. 5 of those are partial dues. 12 lots were set up on payment plans, 4 of which defaulted and have been disconnected. 72 lots owe 3 or more years in dues.

Mark Christie – asked what Trails End is doing about abandoned vehicles. Pam Valenza – stated that she recently found a company that will remove the cars. Will ask the Attorney about legalities. We have a resolution for abandoned trailers that should also covers abandoned vehicles. Will confirm and proceed from there.

- There are only five open seats for the 2008-2010 Board of Directors. Since there were only five applicants, should there still be a meet the candidates meeting? *Discussion held.* Board in agreement to cancel the meet the candidates meeting. The candidates are: Artie Deyns, Bob Personette, Mike Smith, Vinny D'Eusanio and Debbie Shevlin.
- DEP was here in July to inspect the pools. They were in compliance, Trails End needed to fax them the lab reports.
- Clean-up weekend went well. 45 lots participated.
- Campsite Control 15 lots were sent first letters; 22 lots sent second letters for violations and 20 violations from previous letters were corrected.
- Received a letter from lot owner of 3237/3238 requesting that something be done about the flooding on their lot. The lot is the lowest point of a swampy area. Asked the Board for direction on how to resolve the matter. Dale Snyder is not sure on how to resolve it. Should we hire an engineer? *Discussion held*.

Pam Valenza -

- By-Laws are at the printer and will be ready to mail out within a few weeks.
- Lot 5717's appeal for a 10x9 access deck was denied by the Township Zoning Board. The next step would be to appeal to the Pike County Court.

**MOTION:** by Wendy Purdy to appeal lot 5717's permit denial for a 10x9 access deck to the Pike County Court. **Second:** Artie Deyns **Vote:** All in favor Pam Valenza – Attorney sent Stone Mountain Homes a letter breaking the contract with the builder on August 8<sup>th</sup>. No response as of yet.

## **Treasurer's Report**

Artie Deyns – At 100% dues collection as of July 31<sup>st</sup>. Electric below budget. Vehicle maintenance is high.

Pam Valenza – replaced the shanks and teeth on the backhoe's with heavy duty ones. The old ones kept breaking and the cost to replace them individually was \$500 per shank; both backhoes cost \$1830.

Artie Deyns – budget meeting went well. A few items on the wish list for 2008 is replacing the bingo machine, re-doing the teen center, pool awnings and pool furniture. Preliminary increase is \$57 which will be cut down. Next meeting is scheduled for August 25<sup>th</sup> at 10:30am.

Bob Personette – Had 5 grievances at the last meeting, 4 were found guilty and one was not. One property owner will be coming to the Board meeting next month.

# **Property Owners**

Lot #642 – stated that at the July meeting he was talking about decorative lights being on all the time not security lights.

Lot#3824 – asked why people are allowed on payment plans. Maureen Miller – stated that there was problems with payment plans in the past, however now people cannot go on them after April 30<sup>th</sup>.

Pam Valenza – stated that property owners can only go on a payment plan one time.

Lot #3814 – there has been numerous problems with the water going out this year. Suggested that a maintenance man work at night.

Lot#642 – asked why Trails End will be renting the fitness equipment instead of purchasing it or asking for donations.

Lot #3231 – suggested the recreation money left over at the end of the year be out aside for the teen center makeover.

Maureen Miller – stated that at the budget meeting there was discussion about re-doing the teen center.

Lot#1504 – stated he supports the Board's decision on making a fitness center.
